Dear Britax Product Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Britax Child Safety, Inc. has decided that a defect which relates to motor vehicle safety exists in select Britax Boulevard 70-G3, Pavilion 70-G3, and Advocate 70-G3 Convertible Car Seats manufactured between June 1, 2012 and August 31, 2012 for Model numbers E9LJ91A, E9LJ91M, E9LJ91S, E9LJ93P, E9LJ93P, E9LJ93S, E9LK91A, E9LK31A, E9LK31Q, E9LK32D, E9LK32Z, E9LK33Q, E9LL11A, E9LL11Q, E9LL12D, E9LL12Z, E9LG81A, E9LG83N, E9LG83P, E9LG83X, E9LG83Y, E9LL23P, E9LL23P contain a defect which relates to safety. According to our consumer registration records, your Boulevard 70-G3, Pavilion 70-G3, or Advocate 70-G3 Car Seat may be affected.

Description of the Defect

HUGS (Harness Ultra-Guard System) Chest Pads are affixed to the seat shell to ensure proper positioning and provide resistance to the forward movement of your child in a crash, reducing the risk of head injury.



The affected Boulevard 70-G3, Pavilion 70-G3, and Advocate 70-G3 Convertible Car Seats were manufactured with this enhanced harness system that incorporated a softer more pliable, non-toxic HUGS pad intended to provide increased performance and comfort. Britax has received reports that some children bite or chew on the pads and have bitten off small pieces of the pads which could present a choking hazard, especially in infants.

What You Should Do

Britax is providing with this notice a remedy kit that contains two replacement HUGS Pads that are made from a firmer material that will not break apart when children chew or bite the HUGS Pads and an instruction sheet for replacing the pads. Confirm whether your Boulevard 70-G3, Pavilion 70-G3, or Advocate 70-G3 Convertible Car Seat is affected by verifying the model number and date of manufacture as follows:

A. Look for the white label on the child's left-hand side of the seat near the head/ear area. This label displays the seat's serial number, manufacture date, and batch number.



- B. The cover may need to be lifted to view the label.
- C. Look for model numbers and manufacturing dates E9LJ91A, E9LJ91M, E9LJ91S, E9LJ92E, E9LJ93P, E9LJ93S, E9LK91A, E9LK31A, E9LK31Q, E9LK32D, E9LK32Z, E9LK33Q, E9LL11A, E9LL11Q, E9LL12D, E9LL12Z, E9LG81A, E9LG83N, E9LG83P, E9LG83X, E9LG83Y, E9LL21A, E9LL23P, E9LL23Y manufactured between June 1, 2012 and August 31, 2012.

Note: Only Boulevard 70-G3, Pavilion 70-G3, and Advocate 70-G3 Convertible Car Seats made during the period of June 1, 2012 to August 31, 2012 are included in the recall and all other Boulevard 70-G3, Pavilion 70-G3, and Advocate 70-G3 Convertible Car Seats manufactured outside of these dates are not included.

D. If your Convertible Car Seat is affected, carefully read and follow the detailed instructions included in this kit.

Even if your child is not biting or chewing on the HUGS Chest Pads, Britax strongly recommends that you replace the HUGS Pads to prevent this from potentially occurring.
